The 44th Annual Northland Figure Skating Competition will be conducted in accordance with the rules and regulations of U.S. Figure Skating, as set forth in the current rulebook, and/or current Compete USA handbook as well as any pertinent updates that have been posted on the U.S. Figure Skating website.

This competition is open to all eligible, restricted, reinstated or readmitted persons as defined by the Eligibility Rules, and who are currently registered members of a U.S. Figure Skating member club, Learn to Skate USA® member, a collegiate club or who is an individual member in accordance with the current rulebook. Please refer to the current rulebook for non-U.S. citizens.

## SERIES INFORMATION:

Adult beginner, adult high beginner, adult pre-bronze and adult bronze program/free skate events that meet Adult Competition Series guidelines are offered at this competition. Adult Competition Series participants must submit a photo, scanned copy, email attachment or screenshot of the results sheet to adultcompetitionseries@gmail.com by the deadline published in the most recent Adult Competition Series Handbook to receive credit and series points.

## II. ELIGIBILITY

## ELIGIBILITY/TEST LEVEL:

- Skaters must meet at least the minimum singles test requirements for the event's level. A skater's singles test level may be higher than the minimum requirement.
- Skate Up: skaters may skate up one level higher than their minimum test requirement allows.
- Skaters may not register for an event level lower than allowed by their competitive floor. An athlete's competitive floor is set by one of the following scenarios:
- If an athlete has a paid EMS series application for the NQS series, the event level registered for in the most recent NQS will become the lowest level they may compete at in any U.S. Figure Skating sanctioned event.
- If an athlete has a paid EMS series application for the Excel Series, the event level registered for in the most recent Excel series will become the lowest level they may compete in any Excel event. For Well-Balanced and Specialty events the skater will be permitted to register at one level lower than the "floor" set by their excel series entry.
- If an athlete has never had a paid EMS series application in the NQS or Excel series, the athlete may select their level based on their goals and technical skills as long as the minimum test requirements are met. (Note: if an athlete has passed the pre-preliminary singles test, they are no longer eligible for No Test or lower levels).
- Skaters are not permitted to enter an Excel free skate and a Well-Balanced free skate event at the same competition (example: Juvenile Girls Free Skate and Juvenile Girls Excel Free Skate). However, they are permitted to enter an Excel and a Well-Balanced event of different types such as a short program (if stand-alone event option), specialty or showcase events (example: Intermediate Women Short Program and Intermediate Women Excel Free Skate).

Test Level: Competition level is the highest test passed as of the entry deadline; in the discipline the skater is entering OR the level of their EMS Series Application for the NQS or Excel Series which will determine the athlete's competitive floor level. Entrants may skate up one level above that for which they qualify, but they may not skate down in any event. (Exception - Juvenile/Open Juvenile skaters wishing to skate a short program may skate a Juvenile/Open Juvenile Freeskate and an Intermediate Short Program.)

As of December 1, 2022, singles athletes may opt to accelerate their test progression within U.S. Figure Skating and thus compete at level(s) best suited for their technical skillset. Athletes must still meet the minimum requirements for each level and additionally, if participating within the National Qualifying Series (NQS) or National Excel Series (Excel), they will establish a competitive floor (i.e., the lowest level they can compete at).

The competitive floor is determined only by the level selected through the EMS Series Application for NQS or Excel and is not uniquely tied to competition registration (regardless of series participation).

Example \# 1, if an athlete passed their junior free skate test in November and competed in the 2022-23 NQS as a Novice from July - September, they may register for either novice or junior in excel or well-balanced events. The novice level will remain their competitive floor until they complete an EMS Series Application at the junior level or higher for NQS or Excel.

Example \#2, if an athlete passed their juvenile free skate but has not competed in NQS or Excel (i.e., they have not established a competitive floor), they have the option to compete pre-preliminary - intermediate (if skate up is permitted). While the options are wide, U.S. Figure Skating entrusts the coach to guide the athlete to the select the appropriate level for the athlete based on their technical skillset.

Eligibility Notes:

1. The singles free skate test levels will remain as a minimum requirement to compete.
2. Athletes may not skate down in any event.
3. This update does NOT apply to Adult, Showcase and Solo Dance.

Age restrictions/requirements: Singles free skate events (well-balanced program) have the following requirements:

> Juvenile: Girls - 12 years or younger; Boys - 13 years or younger Open Juvenile: Girls - 13 years or older; Boys -14 years or older Intermediate must be under the age of 18
> Adults must be 21 years or older

Skaters entering pre-juvenile and lower events will be divided as closely as possible by age should the number of entries warrant more than one group.

All age classes may be divided or combined depending on the number of entries and at the discretion of the chief referee and/or the competition committee.

## U.S. Figure Skating Nonqualifying Competitions

## EVENT: TEAM COMPULSORY

Teams should be comprised of 3-5 skaters and can be a combination of Ladies and Men. Each skater will do one required element. If there are not five skaters on a team, the skaters may do a maximum of two elements. The elements may be completed in any order but each element shall be allowed only one attempt. Additional elements are not allowed. No music allowed. One skater should perform at a time. Elements are skated on full ice. Referee will indicate when each team should commence but not the individual skaters. Judging done with one mark for each team.

When registering for the competition it is imperative that ONE member of the team register the entire team online. Team registration is separate from skaters' individual event(s). Every team will need a team name and team contact, that person will have access to the competition portal, including registration and payment of the entire team fee of $\$ 100$. In addition, the person registering the team will need to enter each team member's name, date of birth, USFS number, home club, and test levels passed and submit via email to northlandcompetition@gmail.com. This is a fun event and encourages team spirit among the clubs and the skaters.

To be an eligible coach at a nonqualifying competition, coaches must meet the applicable compliance requirements and verified by U.S. Figure Skating. Coach compliance falls into two categories, Coach Compliance (includes choreographers) and Learn to Skate USA® Instructor Compliance. Details regarding compliance requirements can be found HERE. All compliance requirements must be met at the time of check-in to access the competition, no exceptions.

Coaches of foreign athletes: If you are a coach of a foreign athlete only, you are not subject to U.S. Figure Skating coach compliance and will only be asked to provide a letter of good standing for the federation your athlete represents.

## FOREIGN SKATERS:

Non-U.S. skaters intending to register for this competition must set up a non-member account prior to registering for the
competition (click here for HOW TO). This can be done by choosing the "Non-Member? Create Account" option on the Members Only login page.

TEST CREDIT: Skaters that meet the requirements for test credit may request their test credit forms at the registration desk or pre-purchase during registration through EMS. Test Credit Forms must be requested prior to the event listed. Forms must be picked up at the registration desk prior to the end of the competition. All test credit packets will inquire a $\$ 20.00$ fee.

## MUSIC SUBMISSION/UPLOAD:

EMS MUSIC UPLOAD: Competitors participating in events with music are required to upload their music to EMS no later than January 2,2024 11:59pm ET. After this date, skaters will be locked out of this feature and subject to a $\$ 35$ late fee. The late fee will automatically be added to each skater's cart who doesn't meet this requirement by the deadline. Late fees will not be removed under any circumstances and must be paid prior to receiving the skater credential onsite.

Competitors must also have available a backup copy of their competition music on a cell phone and it must be immediately available rink side whenever the skater competes. If the phone does not have the standard round headset connector, an appropriate adapter, such as an Apple Lightning connector or Samsung USB-C adapter is required to be attached. The phone should be presented to the music person with the file ready to play, phone in airplane mode and volume turned to maximum.

## PLANNED PROGRAM CONTENT (PPC) SUBMISSION/UPLOAD - FOR IJS EVENTS ONLY:

EMS PLANNED PROGRAM CONTENT (PPC) - Competitors participating in IJS events are required to submit PPC in EMS no later than January 2, 2023 11:59pm ET. After this date, skaters will be locked out of this feature in EMS and subject to a \$35 late fee. The late fee will automatically be added to each skater's cart who doesn't meet this requirement by the deadline. Late fees will not be removed under any circumstances and must be paid prior to receiving the skater credential onsite.

## IV. COMPETITION DETAILS

FACILITIES: The competition will be held January 18 - January 21, 2024 at the Duluth Entertainment Convention Center (www.decc.org), 350 Harbor Drive, Duluth, MN 55802. The DECC is a two-rink facility with ice surfaces of 190' $x 85$ '. There is a daily parking fee of \$10.00. Concession stands available on premise at various hours (Covid-19 guidelines pending). The nearby Canal Park area offers many different restaurants and is located within walking distance of the DECC.

SCHEDULE: Competitors may be scheduled on any day or time during the announced dates of the competition. The competition and practice ice schedule will be available after the close of entries. All participants will be notified via email once available. Please check the registration desk during the competition as well as the Official Bulletin Board in Edmund Fitzgerald Hall.

LOCKER ROOMS AND CHANGING AREAS: This event will be following the Locker Rooms and Changing Area policy included in the SkateSafe Handbook. Please click here to review the Locker Rooms and Changing Area policy. More detailed information can be found in the SkateSafe Handbook. It is advised to arrive to the rink 45 minutes prior to your scheduled event and be prepared to skate. All locker rooms (if available) will have their doors kept open, there will be no changing areas available. Bathrooms are available throughout the facility; however, skaters must come dressed and ready to skate. There will be "ready areas" available.

## U.S. Figure Skating Travel Policy:

All travel must strictly adhere to Two-Deep Leadership requirements. An Adult Participant cannot transport a Minor Athlete one-on-one and Two-Deep Leadership requirements must be adhered to at all times during In-Program travel, by transporting at least two minors or a second Adult Participant. An Adult Participant cannot share a hotel room or other sleeping arrangement with a Minor Athlete(s). Full details the SkateSafe® Travel Policy and any exceptions can be found starting on page 12 of the SkateSafe $®^{B}$ Handbook.

OFFICIAL NOTICES: An official bulletin board will be maintained at Paulucci Hall near the registration desk. It is the responsibility of each competitor, parent and coach to check the bulletin board frequently for any schedule changes and/or additional information. Skaters are requested to arrive 45 minutes prior to the scheduled time of their event. A tentative schedule of events will be posted prior to the competition.

PRACTICE ICE: Practice ice will be available for purchase via EMS. Additional practice ice information will be available on the www.duluthfsc.org website, EMS, and emails. Refunds will not be given for unused practice ice sessions.

ONSITE REGISTRATION: The registration desk is located in Paulucci Hall and will open at 2 pm on Thursday, January $18^{\text {th }}$, and one hour prior to the first scheduled event on all other days and will remain open through the last event of the day. Skaters are required to check in at least one hour prior to their first event.

PHOTOGRAPHY: An official photographer will be taking action shots of all skaters and events, as well as at awards. Your registration fee includes all photos, including awards, from one event of skaters' choice. Additional photos and/or events will be available to purchase.

VIDEOGRAPHY: Your entry fee includes a video of one event of skaters' choice. Additional videos and/or events will be available to purchase.

PHOTO/VIDEO: Note, per U.S. Figure Skating policy, photographing and/or recording of anyone other than your own skater is strictly prohibited. Please refer to the Basic Ice Usage and Skater Etiquette Information document found in the Club Resource section of Member's Only.

AWARDS: All award ceremonies will be off ice in Paulucci Hall shortly after the final results are posted online.
